Purpose: Drawing on global experiences and perspectives, the Seminar will provide an

opportunity for CEOs of IFACCA national member agencies to hear from their colleagues on issues of leadership in arts funding, to reflect on the challenges of being leaders of government agencies that support the arts and culture, and to share learning about their successes and failures. The seminar will also provide delegates with a chance to build collegial bonds and discuss future

directions for the Federation.

The programme is designed to allow maximum opportunities for participants to share information about the situation, challenges and success, in their countries. In responding to previous seminar feedback we are keen to give ample time for discussion and debate. The amount of expertise as a collective in the seminar is significant and by using an open format, often referred to as Open Space facilitation, we expect to tap into this expertise. Open Space facilitation is a structured format designed to encourage meaningful conversations where you create the topics and where you tap into the expertise and collective knowledge of your fellow Seminar attendees.

Topics:

You will set the topics for the break-out groups in the Seminar. The following may stimulate your thoughts on the topics that you would like to discuss:

- Sustainability in changing local and world economic frameworks, what does this mean for the arts sector? What are some new business models – both in how we invest in the arts but also for the arts organisations we support?
- **Value** What are the new models of measuring 'value in the arts'? How are we capturing and using BIG DATA how can we work together to share this data and knowledge?
- **Diversity** demographics, education levels and economic models are rapidly changing how are we facing these changes?
- Governance What is the governance framework to support innovation in our own organisations and in the arts sector? Do traditional governance frameworks create risk averse cultures and are they counter to the sectors we support?
- Advocacy arts sector issues such as creativity, risk taking and freedom of expression can generate tense and complex debates – what is the role for leaders of government agencies in such situations?
- Capacity building what are our needs? What is working in our jurisdictions? How can we share our knowledge and exchange ideas and people?
- **Soft skills** we discuss hard skills in leadership, but what are the soft skills required to be effective leaders and how do we develop them?

Fort St. Angelo is the jewel in the crown of The Maltese Islands' military heritage. According to legend, the fort stands on the site of a fortified Roman settlement. When the Knights arrived on the Island in 1530, the Fort became the seat of the Grand Master of the Order. It was to play a heroic role in the Great Siege of 1565, when, against all odds, it managed to repel a formidable Saracen armada. The epic resistance of the Knights during the three-month siege gave the Fort its legendary status. It provides majestic views of Valletta.

Head of Monitoring and Evaluation Unit, Ministry of Culture and Heritage Preservation
Bilel has served as a Public Services Advisor at the Ministry of Culture of Tunisia since 2001.
As a public policy specialist, he was assigned in his early career to elaborate a new cultural policy framework based on development projects. Later, he was responsible as a negotiator and as a cultural policy specialist for development oriented international cultural cooperation, namely at the multilateral level (International and regional organizations). Veronica is the Director of International Cultural Cooperation, of the General Directorate of International Affairs of the Secretariat of Culture of Mexico. She encourages, promotes and monitors international cultural cooperation projects; participates in bi-national, regional and multilateral meetings, forums and events related to cultural diplomatic agenda; and conducts negotiations and oversees the implementation of the agreements between the Secretariat of Culture and different international organizations, regions and countries in cultural and artsrelated affairs. She holds a Master of Arts Degree from the Universidad Iberoamericana (IBERO) in Mexico City, a Bachelor's Degree of Arts from the University of the District of Columbia (UDC) in Washington, D.C., and an Undergraduate Degree in International Relations from the Universidad Autonoma de Chihuahua (UACH), Chihuahua, Mexico. During 2015, Ms Ahumada worked as a Professor at the Department of Arts at the Universidad Iberoamericana in Mexico City, lecturing the "Concept of art over time" for students of BA in Humanities. In 2010, she was Coordinator and Professor of Art at CentroNia DC Public Charter School in Washington, DC. From 2001 to 2007, she worked in the Department of the Institute for Mexicans Abroad (IME) in charge of Public Relations and Cultural and Educational programs and events at the Consulate General of Mexico in El Paso, Texas.

Janet Archer, Scotland CEO, Creative Scotland

Janet took up her post at Creative Scotland in July 2013. Since that time she has appointed a new senior leadership team and produced a long term plan for the arts, screen and creative industries in Scotland 'Unlocking Potential, Embracing Ambition'. Alongside this she has simplified Creative Scotland's approach to funding and begun implementing a new People

Strategy for the organisation. Prior to joining Creative Scotland, Janet spent 6 years at Arts Council England as Director, Dance, working as part of the national arts strategy team. She played an active role in developing Arts Council England's 10 year framework for the arts: 'Achieving Great Art For Everyone'. Before joining Arts Council England, Janet spent 16 years with the Newcastle based National Dance Agency, Dance City as Chief Executive and Artistic Director. Janet's work in Scotland includes chairing the artist-led organisation The Work Room based in Glasgow, supporting the British Council in programming their showcases in Edinburgh and as a former dancer, choreographer, founder and Artistic Director of the Nexus Dance, touring into Scotland as well as attending the Scottish Youth Dance Festivals held in Stirling in the 1980s. She is an award winning performer who won the first Cosmopolitan Dancer of the Year Award in 1981.

Martyn Bould, Cayman Islands

Chairman, Cayman National Cultural Foundation

Martyn is President of several property development and holding companies having developed for his own account office buildings, luxury residential condominiums, houses, warehousing, shopping centres and sports clubs. He is an Arbitrator, Mediator and Expert Witness for and Lecturer on, Construction Claims both large and small throughout the Region and was appointed an honorary Fellow of the Cayman Society of Architects Surveyors and Engineers in 2012. Martyn is Chairman of the Cayman National Cultural Foundation and Director of the National Gallery of the Cayman Islands and was appointed a Member of the Most Excellent Order of the British Empire (MBE) by Her Majesty, Queen Elizabeth in 2012.

Simon Brault, Canada

Director and Chief Executive Officer, Canada Council for the Arts

Simon Brault began his five-year term as Director and CEO of the Canada Council for the Arts on June 26, 2014. Active in the cultural sector for over 30 years, he has been a driving force behind a number of major cultural projects, most notably as Administrative Director and Director General of the National Theatre School of Canada, and as a founding member and Chair of Culture Montréal from 2002 to 2014. His first non-fiction book, Le facteur C: l'avenir passe par la culture, explains the dramatic rise of cultural concerns in the public agenda. This highly-acclaimed work was published in English as No Culture, No Future. Simon has received numerous distinctions for his commitment to the social recognition of arts and culture, including the Order of Canada, l'Ordre national du Québec, and more recently the Quebec CPA Order's prestigious Outstanding Achievement Award for bringing together "two worlds that were once disparate – the arts and business – an alliance that significantly benefits society at large."

Nick Capaldi, Wales

Chief Executive, Arts Council of Wales

Nick has been Chief Executive of the Arts Council of Wales since September 2008. Prior to his appointment in Wales, he was Executive Director of Arts Council England South West, and before that Chief Executive of South West Arts. He has been a Board member of Culture South West, and Chair of the Bristol Cultural Development Partnership (a pioneering public/private regeneration initiative). And as Chair of Arts 2000 he led a national organisation commissioning projects across England designed to celebrate the role of the artist. He has also spent time working in festivals and orchestral management. A graduate of Manchester's

Chetham's Music School, the Royal College of Music and City University in London, Nick's career in the arts started as a professional pianist in concert performances as well as broadcasts on radio and television. He holds diplomas in musical performance from the Royal College of Music (DipRCM, ARCM) and the Royal Academy of Music (LRAM). Nick was awarded an Honorary Doctor of Arts by City University London in 2016. He is also a Fellow of the Royal Society of Arts.

Director, National Arts Council of Zambia

Adrian has been working as an arts administrator for close to ten years. He holds an MA in Arts Administration from Columbia, New York and a BA in arts from the University of Zambia. He is currently the Director of the NAC Zambia.

Jane Chu, USA

Chariman, national Endowment for the Arts

Jane Chu is the eleventh chairman of the National Endowment for the Arts. With a background in arts administration and philanthropy, Chairman Chu is also an accomplished artist and musician. She leads a dedicated and passionate group of people to support and fund the arts and creative activities in communities across the nation.

Felipe De Leon, Jr., Philippines

Chairman, National Commission for Culture and the Arts

Felipe is a professor of the humanities and the current Chairman of the National Commission for Culture and the Arts (NCCA). He is concurrently Head of NCCA's Committee on Intangible Heritage and National Committee on Music, and Commissioner of the Sub-Commission on the Arts. He was chairman of the humanities department of the University of the Philippines (UP) Diliman from 1976-82. During his term as the Department Chair, he moved for a major shift from a Eurocentric to a World Art approach, with emphasis on Southeast Asian and Philippine arts. He was President of the National Association for Philippine Psychology in 1985-86. He studied Humanities in the College of Arts and Sciences in U.P. Diliman 1965-69, and took his graduate studies in Music Composition and Philippine Studies in the same university from 1973-76. He also did his musicological studies in the Madras Music Academy in India in 1976-77. Among the honors and recognitions he has received are the U.P. Gawad Chancellor Award, National Research Council of the Philippines Achievement Awardee, Patnubay ng Kalinangan Award from the City of Manila, Outstanding Citizen Award of Quezon City, and NRCP Award of Distinction. He is active in promoting and preserving Philippine indigenous cultural heritage and specializes in aesthetics, music theory, and culture and human development issues. He is a lecturer at the international academic circuit and a professor at the Asian Social Institute on development studies and social transformation courses. He comes from a highly gifted and musical family. His father is the late Felipe Padilla de Leon, National Artist for Music and the composer of two grand operas, Noli Me Tangere and El Filibusterismo, and the most popular Christmas carols Pasko Na Naman, Noche Buena and Payapang Daigidig.

Yan Zhang, Singapore Executive Director, Asia-Europe Foundation

Dong Zanshun, China

Director General, International Liaison Dept, China Federation of Literary and Art Circles (CFLAC)

Mr Dong graduated from the Beijing Normal University in 1988 with a bachelor degree in English language and Literature and a master degree in Education. Since 1988 Mr Dong has worked in the field of cultural exchange at CFLAC. With 25 years of experience in culture and arts management, Mr Dong has built a strong network of many high-profile artists and has extensive knowledge of different art forms. He has successfully organized many cultural events, including the China Today Cultural Week and the China International Folk Art Festival, the key cultural exchange brands of CFLAC.

Staffan Forssell, Sweden

Director General, Swedish Arts Council

Staffan is the Director General of the Swedish Arts Council and has a 20 year career in the field of culture. Mr Forssell has held senior positions in most fields of culture, including music, theatre, dance, film, museums and literature. From 2010 to 2014 he was the Director General of the Swedish Exhibition Agency and from 2008 to 2010 the CEO of the Stage Company in Sundsvall, Sweden. He has also been the managing director of the Swedish Army Museum and of Cosmonova at the Natural History Museum, as well as three years managing the mountain division of the Swedish Touring Club. Mr Forssell has a background as a physicist and prior to his career in culture he spent 8 years in the aviation industry as an officer in the Swedish Air Force where he was a flying weatherman.

Sarah Gardner, Australia Executive Director, IFACCA

Since March 2001, Sarah Gardner has been the founding Executive Director of IFACCA. She was previously the Director, Strategic Initiatives at the Australia Council, where she held various senior executive roles from 1990. She was formerly the Director of Public Affairs for the Australian Bicentennial Authority and a consultant in the private and public sectors for the leading Australian firm Issues Australia. Prior to that she was technical manager with the German company, Schering AG, and worked freelance in the tourism industry and community sector in England, Italy, Scotland and Spain. She has a BSc and Masters in Public Policy from the University of Sydney. In 2015 she was appointed to the expert panel for the UNESCO 2005 Convention on the Protection and Promotion of the Diversity of Cultural Expressions.

Deputy Director, Commonwealth Foundation

Myn comes to the Commonwealth Foundation with extensive and multidisciplinary experience in International Development and Communication including participatory governance, peacebuilding, gender, cultural diversity, communications for development, social marketing and advocacy, capacity development and knowledge management. Most recently, she was the Director-Development of the Canadian International Development Agency (CIDA) funded Afghanistan Technical Assistance Program and was based in Kabul, Afghanistan. Previous to this she was the Canadian Field Program Manager of the CIDA funded Local Governance Support Program in the Autonomous Region of Muslim Mindanao in Southern Philippines. Myn has also worked as a Program Manager at the Laurier Institution, a non-governmental Canadian policy think tank examining the economic and social impact of cultural diversity and peace. She has worked with national and local governments, civil society organisations, international organisations, academia, media and the private sector in Canada, the

Philippines, Sri Lanka and Afghanistan. Myn has an MA in Communication and Development from Simon Fraser University School of Communication in British Columbia, Canada, and has authored, edited and published a number of books on governance, capacity development and knowledge management. Tony is the Chief Executive Officer of the Australia Council for the Arts. Since taking on the role in 2013, Tony has led the organisation through its most significant period of reform, resulting in an ambitious new approach by the Council to investment and advocacy for Australian arts. Tonys' 25 year career in the arts has included leadership roles with a broad range of arts organisations, as well as arts policy work in state and federal government bodies. In the arts sector Tony has held management roles with the Victorian Arts Centre, the Sydney Symphony Orchestra, Musica Viva Australia and the Australian Youth Orchestra. With over a decade working in government bodies Tony's experience includes arts policy development and program delivery in the Victorian Government and five years as Executive Director Arts Organisations with the Australia Council, before taking on the role of CEO.

Elise Huffer, Fiji

Adviser, Human Development Programme, The Pacific Community

In her role with SPC (Fiji), Dr Huffer is responsible for the promotion of culture in the Pacific Islands region. This entails implementation of model laws for the protection of traditional knowledge, the promotion of measures to assist the development of the arts and crafts sector (including the protection and promotion of the natural resources the arts and crafts sectors depend on) and the promotion of cultural epistemology. From 1997 to 2007, Dr Huffer held

positions as Associate Professor and Acting Director, Institute of Pacific Studies Publications/Pacific Studies Program, Pacific Institute of Advanced Studies in Development and Governance (PIAS-DG), at the University of the South Pacific, Suva, Fiji. Dr Huffer's educational achievements include a PhD in Political Science, International Relations, Universite d'Aix-Marseille III; Research scholar, Institut de Recherche Scientifique pour le Developpement en Cooperation (ORSTOM); MA in Political Science, Universite de Toulouse; BA in Political Science, International Relations, University of California, Los Angeles (UCLA).

Daniele Kohn-Stoffels, Luxembourg

Conseiller de Gouvernement 1re classe, Ministry of Culture

Daniele is the deputy head of the Ministry of Culture Luxembourg and a counsellor to the Minister. For many years she carried out the Government's culture policy in the regions and developed further projects specifically for the Eastern part of the country. She was part of the Presidency team and manages the daily business of Luxembourg's Ministry of Culture.

Jozef Kovalcik, Slovakia CEO, Slovak Arts Council

Jozef has been the Chief Executive of the newly established Slovak Arts Council since July 2015. He was previously Vice Rector at the Academy of Fine Arts and Design in Bratislava, where he also taught the theory of art, theory of design and aesthetics. His research has been focused on the relation between high and popular culture and cultural politics. He is the author of two books on the topic, entitled Aesthetics of Popular Culture, which is co-authored by Max Ryyn (Slovart, 2014), and High and Low (in print). He was also an active curator of contemporary art and design.

Ann Larsson, Sweden

Director, The Swedish Arts Grants Committee

Ann is the Director of The Swedish Arts Grants Committee since 2005. The Committee is a government agency responsible to the Ministry of Culture. It's primary function is to promote opportunities for artists to develop their art, to further artistic development, and to support innovative contemporary culture.
