## 1. The Second World Summit – 23-26 November 2003 – put it in your diary!

The Second World Summit on the Arts and Culture, *Creating Connections Trends in Government Support for Artistic Creativity*, will be held in Singapore on 23-26 November 2003. The Summit will be hosted by the National Arts Council of Singapore. Registration and accommodation details will be forwarded in early 2003.

The Singapore Summit will provide excellent opportunities to network with colleagues and debate the sorts of issues currently facing leaders in public financing of the arts and culture. To ensure the relevancy of the program which is currently being planned by IFACCA, we will shortly be seeking your advice about the issues you would like covered and the speakers you would like to nominate.

#### 2. The First General Assembly – 23 November 2003

Immediately preceding the World Summit members of IFACCA will be invited to participate in the inaugural General Assembly which will see both the ratification of the Federation's constitution and the election of its inaugural board.

#### 3. Rockefeller Foundation – financially supporting IFACCA

IFACCA is delighted to announce that the Rockefeller Foundation has generously provided the Federation with a grant of \$US100,000 towards 'the costs of information

sharing and skills exchange programs that promote service to arts agencies serving artists and societies in South East Asia and the Pacific, Latin America, Central and Eastern Europe and Africa'. The funding will be of enormous assistance in expanding the Federation's online content, research capabilities into arts issues and national profiles, support for international meetings and staff exchanges, and in broadening the participation of developing countries in IFACCA board meetings.

## 4. The interim board – an update on activities

The members of the interim board, appointed at the First World Summit, have agreed to continue in their current roles until the first board elections are held in November 2003. Interim Board Members' contact details are listed in the information kit.

The fourth and fifth meetings of the board were held at the National Arts Council of Singapore on 22-23 April and the Museum of Contemporary Art in Barcelona on 7-8 November, respectively. On both occasions the board met with key regional leaders in government, research and the arts. The next board meeting will be held in Sydney, Australia on 31 March-1 April 2003.

Apart from their obvious governance role, Board members play a vital part in raising the Federation's profile and encouraging membership, whether through their public speaking engagements, international travel or interaction with VIPs.

#### 5. The next board – nominations to be called in 2003

In May 2003 we will be calling for nominations for the first full board of IFACCA. The deadline for nominations will be around mid-July. A Nominations Working Group (comprised of members of the interim board) will select from your nominations a list of people with the skills and backgrounds requisite to a diverse membership. These nominees will be presented for election at the General Assembly.

## 6. IFACCA's Constitution - final feedback on the draft

Eight responses were received to the request for feedback on the 'consultation draft' of the constitution circulated in early 2002. In April, the board reviewed the comments in detail and the Federation's lawyer has now finalised the changes. The 'final draft' will be sent to you shortly for another opportunity to comment. Once approved by the board, the 'agreed version' will be forwarded to you in mid-2003. You will be asked to ratify the constitution at the General Assembly.

## 7. Corporate Planning – laying the groundwork for the Federation

The Federation's vision, mission statement and three-year objectives are detailed in the attached information kit. At the April meeting the board conducted a SWOT analysis and a stakeholder analysis, which concluded that IFACCA should:

- Develop concrete projects that have a practical and immediate benefit to members.
- Differentiate itself from other international organisations and collaborate where possible.
- Ensure financial viability organisation through member contributions, funding from private foundations and partnerships with international organizations.

At the November meeting, Dr Jonathan Katz, Chief Executive of the US National Assembly of State Arts Agencies, shared with the board his 30 years' experience in running a service organisation focussed on government funders of the arts. His insights promoted extensive discussion about the functions and priorities of the board and secretariat and proved most helpful to the board in informing its planning.

The Executive Director of the Budapest Observatory (BO), Péter Inkei, also met with the board in Barcelona<sup>1</sup>. Here is an excerpt from his BO Report for November:

... I had been concerned about IFACCA, the world federation of arts councils, to be deemed to the splendid isolation of the Commonwealth, keeping distance from the non-arm's-length formations of public granting to culture.... Yet by the time my turn came to convince IFACCA board ... they had decided to open their doors wide: all institutionalised forms of public support to culture are invited to exchange ideas, experiences and URL addresses...

## 8. Funding models – IFACCA is developing a database of issues

IFACCA is maintaining a 'watching brief' on the funding model issue. The chief questions appear to be: How prevalent are the various models? What is the incidence within and between countries of arts funding at arm's length versus direct ministry or departmental funding? What are the costs and benefits of the various models? What types of government arts support activity are best implemented in each way?

These questions are difficult to answer because of the variations in interpretation of such key terms as 'arms-length' and 'peer-assessment', let alone 'arts' and 'culture'. Global trends in government and international networking add further complexity to the challenge. What is clear is that governments wanting to establish or to improve arts support mechanisms are required to act and make policy decisions. IFACCA is ideally situated to be a source of information on the issues.

## 9. Finances – 2001-02 audit completed

The Federation's auditors, KPMG, have now completed IFACCA's annual financial statements to 30 June 2002. If you are a member, you will receive a copy with this progress report. If you would like to receive the financial report please email us.

# **10.** Membership – new members and affiliates welcomed and 2003 invoices due *New Members*

The reports have also been cited in arts and culture research work -

- D'Art 1, on defining artists for tax and benefit systems, was quoted in Australia's Report of the Contemporary Visual Arts and Craft Inquiry.
- D'Art 2, on international comparisons of cultural statistics, was used for background to Arts Research Seminar 'The Use and Abuse of Comparative Research in the Arts and Cultural Sectors', held in Edinburgh in July 2002.
- D'Art 3, on copyright management systems, was used in a paper for the American Assembly meeting on the arts, technology and intellectual property.
- The D'Art process was acknowledged in Professor J. Mark Schuster's report as an 'encouraging development' in his 2002 report, *Informing Cultural Policy*<sup>3</sup>.

## **Bibliographies**

IFACCA continues to facilitate access to arts and culture literature. Two publications portals were added to the website in August: one linking to the publications pages of arts and culture funding agencies around the world; the other to online arts and culture bibliographies. We anticipate that these portals will become the first point of call for arts and culture analysts undertaking literature searches. We also assisted UK firm, Euclid, in designing ACRONIM, a free online database of arts and cultural research.

## 12. Projects – building links between members

## Mini-summits

Apart from the World Summit, the secretariat would like to work with members to organise mini-summits on key arts topics during 2003 and onwards. Mini-summits offer a focused environment for managers from arts councils and culture agencies to explore major policy concerns, develop joint initiatives and forge ongoing networks. Currently IFACCA is developing plans for a mini-Summit about Indigenous arts policy for 2004. Other possible topics might include art form policies, arts advocacy programs, grants administration or research.

## Future Leaders Exchange (FLEx) program

In early 2002 the pilot program for IFACCA's Future Leaders Exchange (FLEx) was announced. FLEx, designed to build relationships and develop the skills of people working in national arts councils and culture agencies, is intended as a two-way program, placing a senior manager of an arts council or culture agency into a similar agency in a different geographical region.

Although a limited response has been received to date, with the generous support of the Rockefeller Foundation it is expected that this program will be an area of growth in 2003. #### 14. The Secretariat – other items of news

IFACCA's secretariat, an independent not-for-profit company located at the offices of the Australia Council in Sydney, is comprised of Executive Director, Sarah Gardner and Research and Administration Officer, Christopher Madden.

With the Federation's financial and administrative procedures now firmly in place, the secretariat is well placed to promote IFACCA more widely. One of 2002's highlights was the recognition of the Federation in the Declaration and Plan of Action of the first Inter-American Meeting of Ministers of Culture and Highest Appropriate Authorities, held in Colombia in July. The Executive Director also took the opportunity of promoting IFACCA at a Japan-EU Round Table on Cultural Policy in Tokyo in May. A similar opportunity eventuated in August, when Ms Gardner was commissioned by the Singapore National Arts Council to present a three-day staff seminar on the Arts in Australia and the Role of Government.

Background information on IFACCA is available in an increasing number of languages including Japanese, Chinese, French, German, Spanish, Portuguese and English, with an promotional brochure to be produced early in 2003. A PowerPoint presentation is also available on request.

With the approach of the Second World Summit in late 2003, IFACCA is facing a busy year. More than ever we need your help in order to fulfil our brief of creating 'a dynamic network, sharing knowledge and creating understanding to enrich a world of artistic and cultural diversity'.
