On the domestic front, we are delighted that our non-profit charity status has finally been approved, further consolidating our administrative base.

#### World Summits on the Arts & Culture

Report on Second World Summit 2003 We are delighted to enclose our Report on the Second World Summit held in Singapore last November. #### Third World Summit 2006

In May, Risto Ruohonen, Chair of IFACCA, and Sarah Gardner, Executive Director, visited NewcastleGateshead to discuss the bid by Arts Council England (ACE) to host the next Summit. They met with ACE North East's Executive Director, Andrew Dixon, to discuss themes and complementary arts events, visited arts and conference facilities and met with a range of community leaders.

Following further board discussion, the bid was unanimously approved and a joint announcement made on 20 September 2004, receiving widespread media coverage. The media releases are at <u>www.ifacca.org</u>. A Memorandum of Understanding between IFACCA and the ACE was signed in Hanoi in October.

A program will now be created around the theme of the role of the arts and culture in regeneration. As the Summit takes shape, news will be published in ACORNS and <u>www.artsummit.org</u> will be updated in early 2005.

*Fourth World Summit 2009?* We welcome expressions of interest in hosting future Summits.

#### International meetings

Regional meeting – Cork On 20-22 May, we collaborated with the Arts Council of Ireland and the Irish Presidency of the EU, to present a conference on *Networking for the Arts in Europe*. IFACCA was represented by Sarah Gardner and Risto Ruohonen.

#### Mini-Summit – Helsinki

The International Expert Meeting on Media Art and New Media Culture

Policy was held in Helsinki on 22-23 August as an IFACCA mini-summit, attracting 25 participants from nine countries. Jointly organised by the Arts Council Finland and m-cult centre for new media culture, the meeting was held in conjunction with isea 2004, the 12th International Symposium on Electronic Art. The result was the Helsinki Agenda, a strategy document on international development of new media culture policy. In 2005, we will conduct a survey of government support for new media arts practice.

Mini-Summit/Meeting – Montréal On 24 August, in the lead-up to the ICCPR conference in Montréal, IFACCA and the Canada Council jointly hosted a meeting for research managers from IFACCA member agencies. Topics discussed by the 22 participants included cultural indicators, databases of cultural policy research, and IFACCA's research activities. A report was published in ACORNS and presented to the IFACCA board at its Hanoi meeting. Members will have the opportunity to attend another researchers' meeting to be held in 2005.

# **IFACCA** board

#### Meetings

The eleventh meeting of the board was held on 5-6 April in Washington DC, USA, hosted by the National Endowment for the Arts and the National Assembly of States Arts Agencies, whose Director, Jonathan Katz, contributed to the board's planning discussions. The NEA's Chairman, Dana Gioia, joined the meeting to discuss current issues while Americans for the Arts hosted a reception enabling the board to meet members of the local arts community. The major policy discussion was about 'indicators' – resulting in the release of the discussion paper noted below.

At the twelfth meeting, hosted by the Vietnamese Ministry of Culture and Information (MOCI) in Hanoi on 25-26 October, the board discussed the corporate plan and the reports of the Helsinki and Montréal meetings. It also reviewed IFACCA's research activities and new programs and proposed that the secretariat investigate the feasibility of staging leadership forums for the CEOs of national arts agencies. The MOCI provided an engaging program of activities to introduce the board to Vietnamese art and culture.

The next meeting will be held in England in April 2005. If you would like to raise an issue or would like the minutes of previous meetings, please let us know.

Office holders and Life Membership At the Washington meeting, Kim Evans (England) was elected Deputy Chair and Shirley Thomson CC (Canada) was formally farewelled. The board has also farewelled Patricia Quinn (Ireland) and Doreen Nteta (South Africa). In recognition of their contribution to the founding of IFACCA, all three have been appointed as Honorary Life Affiliate Members of the Federation.

# **General Assembly**

#### Founding Charter

### Other meetings

In April 2004, Sarah Gardner and Risto Ruohonen spoke at a conference on Cultural Diplomacy at Columbia University Teachers College, New York, USA. While IFACCA's role in the World Culture Forum in São Paolo, Brazil had to be cancelled at the last moment, Risto represented IFACCA at the Interarts Congress in Barcelona in August.

Our research analyst, Chris Madden, presented a paper on *International Networks and Arts Policy Research* at the ICCPR in Montréal and spoke at a forum in Australia on the economic, social and cultural impacts of the arts.

#### FLEx (Future Leaders Exchange)

We are pleased to report that the inaugural FLEx Fellowship was a great success. Ron Layne, Australia Council for the Arts, undertook a ten-week placement at the Arts Council of Ireland from late in 2003. During his time in Ireland, Mr Layne provided briefings and presentations on the Australia Council, particularly on the policies and strategies of the Audience & Market Development division, and met with arts organisations in Ireland to discuss their audience and market development activities.

An evaluation of the FLEx demonstrated that the two arts councils and Ron benefited from the exchange and that the outcomes would be far-reaching. We encourage members to contact us if they wish to participate in the FLEx program.

#### **Research activities**

#### **Cultural Indicators**

On 22 July, following extensive research by Chris Madden and debate by the board, we released a *Discussion paper on Statistical Indicators for Arts Policy*. We received several excellent responses and we plan to review and update the paper for further discussion in 2005.

#### Arts and Disability

IFACCA's D'art report on arts and disability policies, released on 16 September, was well received. The report outlines concepts and issues surrounding disability and the arts, and explores disability policies and programs adopted by arts funding agencies.

#### Artists' Mobility

In December, we will release our D'Art report on *Artists' International Mobility Programs*. Prompted by a question from Mary Ann de Vlieg of the Informal European Theatre Meeting, and written by Judith Staines, the report highlights a range of policies, strategies, programs, evaluations and resources that aim to promote the international mobility of artists.

#### Arts and Education

In partnership with UNESCO and the Australia Council, IFACCA is assisting Dr Anne Bamford of the University of Technology Sydney, to compile a compendium of research that demonstrates the impact of arts-rich programs on the education of children and young people. IFACCA compiled a database of 150 arts and education experts in over 70 countries to whom we despatched a survey in November. Responses are due in mid-December and Dr Bamford will analyse the results while on study leave at UNESCO, Paris in early 2005. The draft report will be circulated for comment and published prior to the UNESCO Summit on Arts and Education in Lisbon, Portugal, in May 2006.

# Ask IFACCA

The secretariat continues to receive a stream of diverse queries relating to arts and cultural policy. Recent topics include:

- arts funding agency assistance to competitions
- intercountry comparisons of government expenditure on the arts
- arguments to support arts advocacy

Our responses to *Ask IFACCA* queries will be publicly available in early 2005.

#### D'art topics in progress

The D'art topics for which we are currently seeking information include:

- Legal Services for the Creative Sector
- Inter-country comparisons of government arts expenditure
- Status of the Artist legislation and policies.

#### Research contracts

We have been commissioned by the New Zealand Ministry of Culture and Heritage, and by the Australia Council, to research and advise on arts policy matters. We expect both contracts to result in publicly available reports that will contribute to international sharing of information on arts policy.

#### ACORNS

The ACORNS bulletin is now distributed to over 2,100 arts policy makers and researchers in 167 countries.

#### Promote your agency internationally

As well as entries in ACORNS, we can now offer mailing lists for IFACCA member agencies wanting to distribute publications to their international colleagues. We have already assisted in the distribution of the National Endowment for the Arts' *How the United States Funds the Arts*, the Arts Council of Finland's *Arsis 3/04 New Media Arts and*  *Culture,* the Australia Council's *Annual Report 2003-04,* and Professor J Mark Schuster's *Informing Cultural Policy: The Research and Information Infrastructure.* 

#### Secretariat news

In April the Australian Tax Office confirmed that IFACCA's legal entity (International Arts Federation Services Pty Ltd) had been accepted as an Income Tax Exempt Charity. This allows us to operate on a calendar year fiscal basis.
