## Second World Summit on the Arts and Culture

The much anticipated Summit held on 23-26 November 2003, was a huge success for cohosts IFACCA and the National Arts Council of Singapore. Over 150 delegates and speakers attended from 45 countries and every continent. Our one regret was that IFACCA's founding Chair, Dr Shirley Thomson, was unable to attend due to a medical emergency.

Over three days more than 30 speakers and panel members shared their ideas and experiences and the ensuing discussions were honest and open. Keynote addresses were given by Ho Kwon Ping, Marion Pastor Roces and Margaret Wyszomirski. The networking and discussions that took place at meal breaks were often as fruitful as the scheduled sessions!

The website <a href="www.artsummit.org">www.artsummit.org</a> contains the papers and presentations and a full report will be published later in the year.

We would like to thank the Rockefeller Foundation, Commonwealth Foundation, Asia-Europe Foundation, Department of Canadian Heritage and the British Council for their financial assistance, which enabled the participation of speakers and delegates from developing countries. Most importantly

we thank the National Arts Council of Singapore and the Singapore Tourism Board for their enormous support and hospitality.

#### Summit publications

The IFACCA secretariat produced two key publications for the Summit: The IFACCA Directory 2003: National Arts Councils and Culture Agencies which provides contact details and profile information on 162 national arts funding agencies; and IFACCA Research Reports 2002 and 2003 containing seven full D'art reports and two quick-response D'art reports. We also produced an IFACCA mouse mat. Members unable to attend the Summit will be sent the reports and mouse mats. Spare copies can be obtained by contacting info@ifacca.org.

#### Summit survey

A survey of delegates showed very positive results with over half (55%) of respondents rating the Summit as excellent. Almost all (93%) of respondents rated the Summit as either good or excellent.

More than 80% of respondents considered the quality of the panel sessions to be good or excellent, while approximately 94% rated the keynotes and the workshops as good or excellent. Respondents were similarly pleased with the choice of topics for the Summit, with over 80% rating the topics as good or excellent.

Organisational aspects of the Summit also received praise. The duration and cost of the Summit were considered 'just right' by the majority of respondents (98% and 68% respectively). The venue was considered excellent by two-thirds of respondents. Summit scheduling and activities were considered to be good or excellent by the majority of respondents.

We received many suggestions for future Summits, including themes and topics. The IFACCA board will review all suggestions as it prepares for the next Summit.

#### **General Assembly – 23 November**

Following a wonderful Chinese banquet, representatives of 25 of IFACCA's 42 Founding Members gathered for the inaugural General Assembly. Draft Minutes are available on request. The main outcomes of the assembly were:

#### Reports

On behalf of Shirley Thomson, Risto Ruohonen chaired the meeting and Patricia Quinn presented the Chair's report. Ms Gardner reported on the secretariat's progress. A 54-page *Three Year Report to Members* was distributed and copies will be sent to Members unable to attend.

Constitution and Founding Charter
The Federation's founding constitution was ratified unanimously by members. At a ceremony following the assembly a founding charter was signed by all present. We are still awaiting some signatures before creating facsimile versions to send to members.

#### Meetings of the Board

The final meeting of the interim board was held on Sunday 23 November while the new board met on 26 November. Appointment of office holders was the first task - Risto Ruohonen and Patricia Quinn were elected as co-Chairs and Lee Suan Hiang as Treasurer.

The next meeting will be held in Washington on 5-6 April 2004, with the aid of the National Endowment for the Arts and the National Assembly for States Arts Agencies. #### **Asian Chapter**

Following the Summit, the NAC Singapore organised a meeting of IFACCA members and observers from Asian countries to discuss possible collaborations.

#### **ASEF Conference**

The Asia Europe Foundation and the Arts Council of Ireland (in collaboration with IFACCA) held a post-Summit conference on 27 November. The meeting enabled arts policy makers in Asia and Europe to discuss artist mobility and the establishment of a network of Asia-Europe Arts Promotion Agencies called ASEARTS.

- D'Art: For more substantial or common policy questions, we may put your query to the international IFACCA network.
- Forums: For ongoing discussion, we may be able to provide an online forum facility.
